## MAIN POINTS FROM THE GUIDANCE

Our uniform policy has been updated in response to statutory guidance from the Department for Education published on 19<sup>th</sup> November 2021:

*The purpose of this guidance is to ensure the cost of school uniforms is reasonable and secures the best value for money.*

*Parents should not have to think about the cost of a school uniform when choosing which school(s) to apply for. Therefore, schools need to ensure that their uniform is affordable.*

*In considering cost, schools will need to think about the total cost of school uniforms, taking into account all items of uniform or clothing parents will need to provide while their child is at the school.*

*Schools should keep the use of branded items to a minimum.*

*A school's uniform policy should be published on the school's website, be available for all parents, including parents of prospective pupils, and be easily understood.*

*Schools should ensure that their uniform supplier arrangements give the highest priority to cost and value for money (including the quality and durability of the garment).*

*Single supplier contracts should be avoided unless regular tendering competitions are run where more than one supplier can compete for the contract and where the best value for money is secured. This contract should be retendered at least every 5 years.*

*Schools should ensure that second-hand uniforms are available for parents to acquire. Information on second-hand uniforms should be clear for parents of current and prospective pupils and published on the school's website.*

*Schools should engage with parents and pupils when they are developing their school uniform policy.*

## AIMS OF THE POLICY

- To provide a clear definition of the purpose and nature of uniform at Barnburgh.
- To identify our shared views of uniform expectations.
- To identify the roles and responsibilities of all stakeholders.
- To make clear the ways in which we aim to ensure that the policy makes an important contribution to the high expectations in the school.

## EXPECTATIONS

- It is our school policy that all children, from Nursery to Year 6, wear school uniform when attending school, or when participating in school-organised events outside normal school hours. Exceptions can be made by the headteacher for individuals based on welfare, SEND or pastoral reasons.
- We ask children to take a pride in their personal appearance.

## AIMS AND OBJECTIVES

Our policy on school uniform is based on the belief that school uniform:

- promotes a sense of pride in our school
- helps to create a sense of community and belonging towards the school
- identifies the children with the school
- supports our commitment to inclusion
- prevents children from wearing 'fashion clothes' that could be distracting in class
- is practical, smart and designed with health and safety in mind
- is considered good value for money by most parents

## MAKE UP, NAIL VARNISH AND TATTOOS

We do not allow children to wear make-up, nail varnish or temporary tattoos.

## HAIR ACCESSORIES

- Children with long hair must have it tied back to minimise the risk of accidents.
- Only plain black, brown, navy or beige bobbles may be used to tie hair back.
- Hair accessories such as ribbons, hair slides or hair bands may be worn in line with our school colours.
- Hair should not be dyed extreme colours.
- Very short hairstyles should not include razor patterns.

## JEWELLERY

- Jewellery of any sort will not be permitted.
- If a child intends to have their ears pierced parents should ensure this takes place at the start of the 6 week break so they will be in a position to remove their earrings for school by September. Where this is not possible, parents will be asked to cover their child's studs with plasters or tape. The child will not be permitted to take part in PE sessions during this time and their play time will be monitored. Barnburgh Primary Academy does not accept responsibility for any injury caused to a child as a result of wearing earrings.
- Any child who comes to school wearing earrings will be asked respectfully to remove them. **School staff are not permitted to do this.** If a child is unable to remove their earrings, a phone call will be made to parents or carers requesting that they come to school to remove them. Children will not be able to participate in PE sessions wearing jewellery of any type.
- A small plain watch may be worn in Key Stage 2 but this must be removed for PE sessions and play timesessions. Children will not be permitted to wear any watch that beeps or buzzes.
- Children are not permitted to wear a Fit Bit or any smart watch.

## CLOTHING

Our uniform consists of the following;

- A navy-blue jumper or cardigan with or without the school logo
- Grey trousers, skirt or tailored shorts
- Plain black leggings or cycling shorts may be worn under grey skirts or dresses
- White or navy-blue polo shirt with or without the school logo
- Blue gingham school dress
- Plain white, grey or black socks or plain grey tights

**Children in Nursery and Reception do not require a PE uniform. Children from years 1 to 6 require a PE uniform.** Our PE uniform is as follows;

- Plain navy blue t-shirt with or without the school logo (no branded logos)
- Plain black shorts, leggings or cycle shorts (no branded logos)
- Plain black tracksuit bottoms (no pattern, branded logos etc)
- Plain navy-blue sweatshirt (no hood, no pattern, no branded logos)
- Plain black trainers that are suitable for outdoor sport.

Our uniform can be purchased from any retail store. Uniform items that include our school logo can be purchased at Cliffs School Wear.

## FOOTWEAR

Children are required to wear

- A pair of plain black shoes, trainers or pumps **with their school uniform**. Shoes, trainers or pumps with coloured laces, logos or soles will not be permitted. All footwear should be flat.
- A pair of plain black trainers **with their PE uniform**. Trainers with coloured laces, logos or soles will not be permitted.
- Children have permission to bring wellies or boots to play outside in on wet days. They should bring these in a bag to change in and out of at playtimes and dinnertimes.

## BAGS & ACCESSORIES

In an effort to keep our corridors and cloakrooms clear and safe, children are only permitted to bring the following types of bags into school:

- a small canvas bag
- a small shoe-bag
- a book bag. Please note, book bags with our academy logo can be purchased at Cliffs School Wear.

Children are asked not to bring ruck-sacks because they are too large to fit in the children's lockers. Children do not need to bring pencil cases or any other type of equipment to school unless specifically requested by a class teacher.

## THE ROLE OF PARENTS

- Parents should ensure that their child has the correct uniform and PE kit, and that it is clean, in good repair and that their child's name is written on all items.
- If a parent has difficulties, for any reason, with fulfilling this request, they are asked to speak confidentially to a member of staff to discuss the issues. Parents should be assured that we will do all we can to help.
- If a child arrives at school not meeting the expectations for our school uniform, a phone call will be made to parents providing them with an option to come to school to make the required changes or to give school staff permission to make the required changes (with the exception of removing earrings). This will be applied for any child without the appropriate PE kit.
- We welcome children from all backgrounds and faith communities. If there are serious reasons, for example on religious grounds, why parents want their child to wear clothes that differ from the school uniform, the school will consider such requests sympathetically. If any parent would like to request a modification to the uniform policy they should, in the first instance, contact the headteacher.

## THE ROLE OF GOVERNORS

- The governing body supports the headteacher in implementing the school uniform policy. It considers all representations from parents regarding the uniform policy and liaises with the headteacher to ensure that the policy is implemented fairly and with sensitivity.
- It is the governors' responsibility to ensure that the school uniform meets all regulations concerning equal opportunities.
- Governors ensure that the school uniform policy enables children to dress sensibly, in clothing that is hardwearing, safe and practical.

## MONITORING AND REVIEW

The governing body monitors and reviews the school uniform policy by:

- seeking the views of parents to ensure that they agree with and support the policy
- considering, with the headteacher, any requests from parents for individual children to have special dispensation with regard to school uniform.
